

# NEWSLETTER

Dear Members,

I wish you all a happy New Year. Now that 2011 has arrived, we can start to think about the new cricket season. In this newsletter there are details of a number of pre-season events of interest to members.

Since the last newsletter our Annual General Meeting took place on 4 November at the Reigate Manor Hotel. We had the pleasure of Paul Baldwin as our guest speaker. Paul told us about his amazing journey from umpiring club cricket in Germany to standing with Simon Taufel in an one day international between Scotland and England, and onto the First Class reserve list in 2010. The [minutes of the AGM](#) are now on the association's website. John Moulton, who many of you will know as an instructor on our Level 1 umpire courses, took over as our Vice Chairman from Lorraine Elgar. All other officers were re-elected.

Following the AGM, we held a successful ECB Level 1 Umpire course over two consecutive Saturdays in November with a full class of 20 students attending. Of the 19 who went onto sit the exam, 14 passed and congratulations go to all of those (see page 3). I am aware that Graham Cooper (the SCB ACO Education Officer) has yet to receive certificates from the ECB ACO but he will send onto the successful candidates as soon as does so.

Looking ahead, we are re-running the Level 1 Umpiring Course on 5/12 March 2011 alongside an ECB Level 1 Scorers Course. This is the first scorers course that we have run in many years and are indebted to West Surrey instructors for their help taking this forward. There are plenty of places left on the scorers course but half of the places on the umpire course have already been taken. Please pass details to anyone who you know may be interested. We are also running two other training events before the new season: an interactive session at Lord's and a seminar outlining the recent changes to the Laws. More details can be found over the page.

More immediately, we are holding a pre-season dinner on 18 February at the Reigate Manor Hotel. This is a change from the venue we have used in recent years. There is a three-course set menu (with vegetarian option) including coffee at £20 per head. This is not a formal cricket dinner but more of an informal occasion for members to socialise and swap cricketing stories.

## HOW GOOD ARE YOUR LBW DECISIONS?

We've all seen the use of Hawk-Eye™ in televised Test Matches. The software manufacturer claims it can accurately pinpoint the speed, line and length of each delivery bowled. Now ESCUSA is providing an opportunity for you to use the technology to sharpen your skills on LBW decisions in an interactive training session at the Lord's indoor school.



The session will run for a total of 2 hours and includes time in the nets and in the Analysis Suite reviewing the action. The event is restricted to ten members, each of whom will get the chance to stand behind the stumps at the bowlers end for 1 or 2 overs. During that time you will need to note down where you think the ball pitched, where it struck the batsman and to judge whether or not the ball would have gone onto hit the stumps. At the end of the net session we will then review each delivery and see how you got on.

The session will take place at Lord's on **Wednesday 16 March 2011** from 7pm to 9pm. ESCUSA is part-subsidising this event and the charge per participant has yet to be agreed, but likely to be in the region of £15 per person.

We are inviting expressions of interest from ESCUSA members by the 4 February. In the event of it being over-subscribed, your committee will decide upon the criteria for allocating places and these will be confirmed by 16 February 2011. 


